## Information on the processing of personal data pursuant to art. 13-14 EU Reg. 2016/679

### Data subjects: User contact details section.

Industria Chimica Reggiana I.C.R. S.p.A. as Data Controller of your personal data, pursuant to and for the effects of the EU Regulation 2016/679 hereinafter referred to as 'GDPR', hereby informs you that the aforementioned law provides for the protection of the data subjects in terms of the processing of personal data and that this processing will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be processed in accordance with the legislative provisions of the aforementioned law and the confidentiality obligations laid down therein.

Purposes of processing: specifically, your data will be processed for the following purposes related to the implementation of obligations related to legislative or contractual obligations:

- Entering contact data in the database
- Respond to your requests

The processing of functional data for the fulfilment of these obligations is necessary for a proper management of the relationship and their granting is mandatory to implement the purposes indicated above. Processing methods: your personal data may be processed in the following ways:

- processing using electronic calculators

Each processing is carried out in compliance with the methods set out in articles. 6 and 32 of the GDPR and through the adoption of the appropriate security measures.

Communication: your data will be communicated exclusively to competent and duly appointed persons for the performance of the services needed to correctly manage the relationship, with a guarantee of protection of the rights of the data subject.

Your data will only be processed by personnel that is expressly authorized by the Data Controller and, in particular, by the following categories of employees:

- Competent office to respond to the request

Your data may be communicated to third parties that have been duly appointed Data Processors, in particular:

- Outside consultants

Spreading: Your personal data will not be disclosed in any way.

Retention Period: Please note that, in compliance with the principles of lawfulness, limitation of purposes and data minimisation, pursuant to Article 5 of the GDPR, the retention period of your personal data is:

- established for a period of time that does not exceed the services provided

You have the right to obtain from the data controller the deletion (right to be forgotten), limitation, updating, correction, portability, opposition to the processing of personal data concerning you, and more generally, you can exercise all the rights provided by Articles 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

### EU Regulation 2016/679: Articles. 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the data subject

1. The data subject has the right to obtain confirmation of whether or not personal data concerning him exists, even if they are not yet registered, and their communication in intelligible form.

2. The data subject has the right to obtain the indication of:

- a. the origin of the personal data;
- b. the purposes and methods of processing;
- c. the logic applied in case of treatment carried out with the aid of electronic instruments;
- d. the identifying details of the data controller, the managers and the designated representative according to Article 5, paragraph 2;
- e. the subjects or the categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the territory of the State, managers or agents.

3. The data subject has the right to obtain:

- a. update, rectification or, when it has an interest, the integration of data;
- b. the deletion, transformation into anonymous form or blocking of the data processed unlawfully, including data which is retained unnecessarily in relation to the purposes for which the data were collected or subsequently processed;
- c. the proof that the operations referred to in letters a) and b) have been brought to the attention, including with regard to their content, of those to whom the data have been communicated or disclosed, except in the case in which this fulfilment proves impossible or involves a use of means that are manifestly disproportionate to the protected right;
- d. data portability.

4. The data subject has the right to object, in whole or in part:

- e. for legitimate reasons concerning the processing of personal data concerning them, even if pertinent to the purpose of the collection;
- f. to the processing of personal data concerning them for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
